Jewish Women's Foundation (JWF) of New Jersey

- Donor-advised fund (DAF) housed at the Jewish Community Foundation of Greater MetroWest
- Giving Circle with approximately 50 trustees, 19 joined in last 2 years and 2 re-joined after lapsing
- Mission is to fund projects that support/empower women and/or girls
- Two grant cycles Small grants (up to \$2500) in the fall, and Large grants (\$25-30,000) in the spring
- Our motto is "Giving together, granting for change"
- Thoughtful PROCESS to ensure that we could maximize involvement to make "giving together" happen
 - Process is important for continuity
 - Process was important consideration as JWF migrated to Zoom for meetings in 2020
 - Process necessitated by almost doubling our membership within a short period of time
- Opportunity for committee involvement (programming, finance, membership, etc.) but granting is essentially run by the Cochairs and the entire membership IS the committee

Step 1 (Fall Season) Trustee Education and Training

- Fall grant cycle -- Smaller grants so it feels less threatening for newcomers to be part of the process and offer opinions
- Paired new trustee with experienced trustee to review an application and present at a meeting
- Many of these new trustees then rose to the challenge of leading site visits in the large grant cycle, i.e., created a stepladder for leadership development

About our Spring Grants Cycle

3-4 grants (year-dependent) for \$25-30,000

We give locally, and there is no requirement for giving Jewishly in this cycle



EARLY JANUARY - RFPs (Requests for Proposals) go out to 150 agencies



END OF JANUARY - Extensive Letters of Intent (LOIs) are submitted by agencies to JWF



MID-FEBRUARY – LOI Bucket Meetings via Zoom to narrow the list to 15-20 semi-finalists



EARLY MARCH – LOI Decision Meeting, trustees meet via Zoom to determine 7-10 finalists



EARLY APRIL – Finalists submit complete applications



MID-MAY – Site Visits in-person




EARLYJUNE - Presentations of Executive Summaries to the Trustees and Final Vote via Zoom



EARLY JULY - Grants disbursed at the beginning of the next fiscal year

Step 2: LOI Bucket Meetings

- This year and last, over 50 grant applications
- Local need is tremendous and, for the most part, the applications were good ones and met JWF's mission
- Not a thematic process. Address any projects that support or empower women and/or girls
- Impetus for the Bucket process was based on:
 - involving a large number of members
 - involving new members, and
 - needing a good system to evaluate need with an overwhelming number of programs



Bucket Meeting Categories

- Divided into buckets as follows
 - Reproductive Health
 - Leadership
 - Mental Health (Substance Abuse Recovery)
 - Domestic Abuse
 - Education
 - Empowerment

Health & Wellness, Seniors Food Insecurity, Period Poverty

Career Readiness, Financial Self-Sufficiency

Homelessness, Justice


Immigrants, Disabilities


(In 2021, also had buckets for Veterans, Refugees)



How-to of Bucket Meetings

- Used a form (free at Signupgenius.com) to have women register for meetings based on the time or bucket that interested them most
- Held at different times of day over a two-week period in February
- LOIs were sent out in advance for pre-reading
- Up to 6 women at each meeting via Zoom
- Lasted about an hour
- Each LOI was discussed and the group members voted for green, yellow or red
- From each meeting, 1 or 2 were pushed ahead to the next stage,
 LOI Decision Meeting in early March





LOI Decision Meeting

- Open to all trustees via
 Zoom. Scheduled for early
 March
- Grants Co-chairs presented on the top 14 - 20 (yeardependent) with slides, approximately 6 minutes each
- This year, conducted Zoom poll with choice of 7 from total pool
- Top vote-getters advanced to next round for submitting full grant proposals and site visits
